**RESOLUTION AUTHORIZING THE DISPOSAL OF
SEVEN CLEAR CREEK COUNTY VEHICLES**

WHEREAS, pursuant to C.R.S. § 30-11-101(1)(c), the Board of County Commissioners for Clear Creek County, Colorado, is empowered to sell, convey, or exchange any real or personal property owned by the County; and

WHEREAS, Clear Creek County desires to dispose of seven vehicles in its fleet that are no longer being used; and

WHEREAS, the seven vehicles proposed to be disposed of are 1) a 2022 EZ Liner Striping Machine Model AL120-EZ, VIN# 1C 02362PS, with approximately 527 hours of use, and an approximate value of \$6,000.00; 2) a 1793 General Trailer, VIN# 9S7327, with an approximate value of \$750.00; 3) a 2008 Western Star Dump Truck Model 4900SA, VIN# 5KKKALCV78PZ74266, with approximately 83,474 miles and an approximate value of \$65,000.00; 4) a 1976 Fruehoff Tanker Trailer, VIN# OMX724410, with an approximate value of \$5,000.00; 5) a 1999 Stewart Stevenson Snow Blower Model SSLB700, VIN# 2017H, with approximately 52 hours of use and an approximate value of \$22,000.00; 6) a 2001 Caterpillar Motor Grader Model 140G AWD, VIN# 72V14246, with approximately 5,373 hours and an approximate value of \$39,900.00; and 7) a 2001 Ford F-250, VIN# 1FTNF21S31EB60037, with approximately 187,959 miles and an approximate value of \$3,875.00; and

WHEREAS, these seven vehicles have been determined to be in fair condition, and Clear Creek County Public Works recommends they be sold by public auction; and

WHEREAS, the Board of County Commissioners of Clear Creek County, Colorado desires to facilitate the disposal of these vehicles in the most convenient way possible.

NOW, THEREFORE, BE IT RESOLVED, that the above mentioned vehicles may be disposed of by public auction.

BE IT FURTHER RESOLVED, that Clear Creek County Public Works Director Stoy Streepey is authorized to execute on behalf of Clear Creek County, Colorado, title and other documents reasonably necessary to transfer ownership of these vehicles from Clear Creek County to the purchaser.
