**RESOLUTION TO RATIFY 2021 ORIGINAL AND SUPPLEMENTAL  
APPROPRIATIONS FOR CLEAR CREEK COUNTY FUNDS**

**WHEREAS**, pursuant to §29-1-109, C.R.S., the Board of County Commissioners adopted Resolutions 20-111, 21-80, 21-85, and 21-104 (collectively, “Resolutions”), appropriating amounts budgeted for fiscal year 2021 and authorizing certain transfers between funds; and

**WHEREAS**, some of the numerical data/amounts, and related information, within these Resolutions are inconsistent; and

**WHEREAS**, the County desires to resolve the inconsistent information and state affirmatively the final 2021 appropriated amounts by fund.

**NOW, THEREFORE, BE IT RESOLVED** that the Clear Creek Board of County Commissioners ratifies the final 2021 fund appropriations for the reasons stated above, as presented in the following table:
