



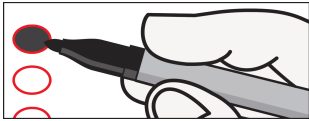

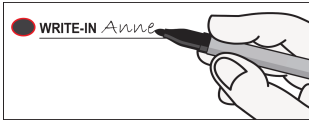

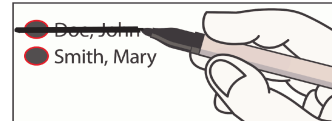
Instructions

<p>Ballot Measures</p> <p>Ballot questions referred by the general assembly or any political subdivision are listed by letter, and ballot questions initiated by the people are listed numerically. A ballot question listed as an "amendment" proposes a change to the Colorado constitution, and a ballot question listed as a "proposition" proposes a change to the Colorado Revised Statutes. A "yes/for" vote on any ballot question is a vote in favor of changing current law or existing circumstances, and a "no/against" vote on any ballot question is a vote against changing current law or existing circumstances.</p>	<p>Proposition 114 (STATUTORY)</p> <p>Shall there be a change to the Colorado Revised Statutes concerning the restoration of gray wolves through their reintroduction on designated lands in Colorado located west of the continental divide, and, in connection therewith, requiring the Colorado parks and wildlife commission, after holding statewide hearings and using scientific data, to implement a plan to restore and manage gray wolves; prohibiting the commission from imposing any land, water, or resource use restrictions on private landowners to further the plan; and requiring the commission to fairly compensate owners for losses of livestock caused by gray wolves?</p> <p style="text-align: center;"> <input type="radio"/> YES/FOR <input type="radio"/> NO/AGAINST </p>	<p>County Ballot Measures</p> <p>CLEAR CREEK COUNTY BALLOT ISSUE 1A</p> <p>WITHOUT RAISING THE MILL LEVIES FOR THE 2021 COLLECTION YEAR AND IN ORDER TO MAINTAIN COUNTY LEVELS OF SERVICES, SHALL CLEAR CREEK COUNTY BE ABLE TO THEREAFTER ANNUALLY ADJUST ITS MILL LEVIES FOR THE PURPOSE OF MAINTAINING PROPERTY TAX REVENUES THAT WOULD OTHERWISE BE LOST AS A RESULT OF STATE IMPOSED REDUCTIONS, IF ANY, MADE TO THE RATIO OF ACTUAL VALUATION USED TO DETERMINE ASSESSED VALUATION OF PROPERTY, SO THAT THE ACTUAL PROPERTY TAX REVENUES GENERATED BY THE COUNTY'S MILL LEVIES ARE EQUAL TO THE ACTUAL PROPERTY TAX REVENUES THAT WOULD HAVE BEEN GENERATED HAD SUCH REDUCTIONS NOT OCCURRED; AND SHALL THE COUNTY BE AUTHORIZED TO COLLECT, RETAIN AND SPEND ALL REVENUES COLLECTED AS A RESULT OF SUCH ADJUSTMENTS AS A VOTER APPROVED REVENUE CHANGE AND AN EXCEPTION TO THE LIMITS THAT WOULD OTHERWISE APPLY UNDER ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION OR ANY OTHER LAW?</p> <p style="text-align: center;"> <input type="radio"/> YES/FOR <input type="radio"/> NO/AGAINST </p>

<p>Amendment 77 (CONSTITUTIONAL)</p> <p>Shall there be an amendment to the Colorado constitution and a change to the Colorado Revised Statutes concerning voter-approved changes to limited gaming, and, in connection therewith, allowing the voters of Central City, Black Hawk, and Cripple Creek, for their individual cities, to approve other games in addition to those currently allowed and increase a maximum single bet to any amount; and allowing gaming tax revenue to be used for support services to improve student retention and credential completion by students enrolled in community colleges?</p> <p style="text-align: center;"> <input type="radio"/> YES/FOR <input type="radio"/> NO/AGAINST </p>	<p>Proposition 118 (STATUTORY)</p> <p>Shall there be a change to the Colorado Revised Statutes concerning the creation of a paid family and medical leave program in Colorado, and, in connection therewith, authorizing paid family and medical leave for a covered employee who has a serious health condition, is caring for a new child or for a family member with a serious health condition, or has a need for leave related to a family member's military deployment or for safe leave; establishing a maximum of 12 weeks of family and medical leave, with an additional 4 weeks for pregnancy or childbirth complications, with a cap on the weekly benefit amount; requiring job protection for and prohibiting retaliation against an employee who takes paid family and medical leave; allowing a local government to opt out of the program; permitting employees of such a local government and self-employed individuals to participate in the program; exempting employers who offer an approved private paid family and medical leave plan; to pay for the program, requiring a premium of 0.9% of each employee's wages, up to a cap, through December 31, 2024, and as set thereafter, up to 1.2% of each employee's wages, by the director of the division of family and medical leave insurance; authorizing an employer to deduct up to 50% of the premium amount from an employee's wages and requiring the employer to pay the remainder of the premium, with an exemption for employers with fewer than 10 employees; creating the division of family and medical leave insurance as an enterprise within the department of labor and employment to administer the program; and establishing an enforcement and appeals process for retaliation and denied claims?</p> <p style="text-align: center;"> <input type="radio"/> YES/FOR <input type="radio"/> NO/AGAINST </p>	
<p>Proposition EE (STATUTORY)</p> <p>SHALL STATE TAXES BE INCREASED BY \$294,000,000 ANNUALLY BY IMPOSING A TAX ON NICOTINE LIQUIDS USED IN E-CIGARETTES AND OTHER VAPING PRODUCTS THAT IS EQUAL TO THE TOTAL STATE TAX ON TOBACCO PRODUCTS WHEN FULLY PHASED IN, INCREMENTALLY INCREASING THE TOBACCO PRODUCTS TAX BY UP TO 22% OF THE MANUFACTURER'S LIST PRICE, INCREMENTALLY INCREASING THE CIGARETTE TAX BY UP TO 9 CENTS PER CIGARETTE, EXPANDING THE EXISTING CIGARETTE AND TOBACCO TAXES TO APPLY TO SALES TO CONSUMERS FROM OUTSIDE OF THE STATE, ESTABLISHING A MINIMUM TAX FOR MOIST SNUFF TOBACCO PRODUCTS, CREATING AN INVENTORY TAX THAT APPLIES FOR FUTURE CIGARETTE TAX INCREASES, AND INITIALLY USING THE TAX REVENUE PRIMARILY FOR PUBLIC SCHOOL FUNDING TO HELP OFFSET REVENUE THAT HAS BEEN LOST AS A RESULT OF THE ECONOMIC IMPACTS RELATED TO COVID-19 AND THEN FOR PROGRAMS THAT REDUCE THE USE OF TOBACCO AND NICOTINE PRODUCTS, ENHANCE THE VOLUNTARY COLORADO PRESCHOOL PROGRAM AND MAKE IT WIDELY AVAILABLE FOR FREE, AND MAINTAIN THE FUNDING FOR PROGRAMS THAT CURRENTLY RECEIVE REVENUE FROM TOBACCO TAXES, WITH THE STATE KEEPING AND SPENDING ALL OF THE NEW TAX REVENUE AS A VOTER-APPROVED REVENUE CHANGE?</p> <p style="text-align: center;"> <input type="radio"/> YES/FOR <input type="radio"/> NO/AGAINST </p>
